No votes were taken and member attendance varied throughout the day.

### **Lake Winnepesaukee Activities and Summary**

The meeting was hosted by Ryan Cardella and East Coast Flightcraft, at the Winnepesaukee Pier.

- 1) Remarks from Lake Winnepesaukee Association: Pat Tarpey gave an update on the lake association's activities, including preparation and implementation of watershed-based plans. Brianna Rossiter gave an overview of their voluntary, non-regulatory Keep Winni Blue program that provides advice to homeowners about actions individuals can take on private land to protect the lake. Milfoil control efforts were also discussed.
- 2) Members joined Marine Patrol on a boat tour around Governor's Island and Meredith Bay to observe shoreland properties and active projects, and the degree to which homeowner practices do and do not align with permit requirements or best practices to protect shorelands. Darlene Forst and Calvin Diessner educated members about the requirements of the Shoreland Water Quality Protection Act.
- 3) Ryan Cardella gave a tour of his company's facilities at the Winnepesaukee Pier, described patterns of public use of the Pier and Weirs Beach, and discussed future plans for his property. He also talked about Marine Trades boater education efforts, particularly with respect to safe wake boating practices.
- 4) East Coast Flightcraft took members out in two wake boats to demonstrate the size and attenuation of wakes during typical cruising and wake surfing conditions. Afterwards, members discussed wake boat impacts relative to water depth, speed, and operating conditions. Ryan Cardella offered to follow up with additional information about wake boat operating depths.
- 5) Steve Wingate described the results of a study he conducted on phosphorus and turbidity levels in Lake Winnepesaukee. Results showed that neither turbidity nor phosphorus levels rose significantly during period of low to moderate boating activity, but did rise significantly during periods of moderate to high boating activity.
